This will allow any individual unable to attend a service to register and pay their condolences. The registry link allows an individual to safely register from home on any desktop, Pc, tablet or cell phone.

This option will also enable those unable to attend to make a safe and secure monetary donation electronically thru a Pay-Pal account.
